REPLACEMENT POLICY: Renter is fully responsible for the loss, theft or destruction of said property from all causes and agrees to pay the owner the replacement cost of the property in such event. In the event of damage and/or partial destruction from any cause, renter agrees to pay to the owner the reasonable cost of repair to said property, to be determined in the sole discretion of Owner. Products must be returned with all accessories and parts intact and in proper working order. Any excess damage to rental equipment, aside from normal wear, will be replaced at the expense of the renter. Full replacement costs are available upon request.

## **Release of Liability**
